Mrs Knight from Haselbury Plucknett Parish Council came to the meeting to update us on the progress they have made regarding the safety on the A30. They are still gaining information and recently had representatives from the Highways Department at their Parish Council meeting.

As a result of this there was a consensus that there had been a reduction of accidents at the double bend after Barrows garage (in the direction of Crewkerne from East Chinnock), however the consensus was that the bend near North Downs Farm was still dangerous.

They have also met with David Laws MP who has suggested that a meeting is set up with the Police, Highways, Cathy Bakewell and any other affected parties. Mrs Knight asked if East Chinnock wished to send a representative to the meeting which is likely to be held on the 29th September 2009. It was agreed that this would be a good idea and Mr Jones and Mr Churchill volunteered to attend.

81. Matters arising from the minutes

The Hollow. The Chairman updated the meeting on the recent activity regarding the Hollow. The foliage and overhanging trees have been removed. The new silt trap has been put in place and the drains have been cleared. There has been some repair work on the road.

However there remains :-

- Some large pot holes on the left hand side as you drive up the Hollow. Highways are aware of this. Mr Churchill will chase up activity on this especially in light of the Tour of Britain where cyclists will be going up the Hollow as part of a special stage.
- The signage and markings on the road have not been repainted. This is still to be done and the contractor is aware of this
- A resident has stated that the silt trap "clanks" when vehicles go over it. This has been reported to Highways.

In respect of the traffic issues (numbers of and speed), Mr Churchill is due to meet the Highways representative on the 9th September to have a full understanding of the history of the situation. The Clerk has received the data from the traffic survey that took place in 2005 and this has been passed to the Chairman. Mrs Bakewell has also met with Mrs Carter regarding this matter and it was agreed that all action would be on hold until the results of the traffic survey that is due to take place soon.

- *Minute 25 Ash Tree*. Since the last meeting the district council arborist has been to see the tree and reported back to Mr Pallister. It was felt that the tree was likely to affect the overhead cables in the near future. Pollarding was not recommended. His suggestion was to plant a hazel hedge and coppice it. It was felt that a hazel hedge was not a good idea as it is would block the view into the playing fields and play area. After much discussion it was proposed that the Parish Council proceed with the original decision to fell the tree and plant 3 smaller trees along the boundary.
 - Mr A Harris has been asked to get quotes
 - to fell the tree
 - for replacement trees
 - for tree surrounds to protect the new trees
- *Minute 13 Dips on A30.* The major dip has now been dealt with and our thanks to Mrs Bakewell for chasing this matter and to Highways for carrying out the work.
- *Minute 64 Play Area Report.* Mr Pallister has spoken to the Senior Officer who has advised us that we should read the reports and take note of the comments. If no action is to be taken then this should be minuted. We should continue to take action where appropriate
- *Minute 64 Pathway to Cott Farm.* An estimate of £50k has been received to create a pathway. It was felt that this was extremely excessive and not a true reflection of what could be put in place. The minutes from the last meeting, which had been previously circulated to Members were approved discussed. Mrs Merchant wished Minute 25 regarding the Ash Tree to state that the District Councils tree specialist had said that "the tree is currently safe and there is no imperative to fell it". The Chairman signed all other pages of the minutes as a true reflection but asked that the Clerk amend Page 2 as discussed.

100. Matters arising from the minutes

• *The Ash Tree*. Further to recent discussions Mrs Merchant said that she had 30 villagers supporting her request that the tree is not felled. She felt that the tree was not interfering with the cables and that felling it would be a waste of village money. The Tree warden was in agreement with her. As this matter has been voted on twice before the Councillors stuck to the decision to fell the tree. Mrs Merchant wished to be named as the Councillor who objected to this.

It was proposed and seconded (vote 6 to 1) for asking Mr Martin to fell the tree at a cost of £350. Mr Harris was asked to arrange this and make sure that the wood is left. The original decision was to plant Cherry trees. The Tree warden asked that the Councillors consider Mountain Ash instead of a height between 6-8 ft. This was agreed and Mr Harris will get costs for this. He also investigated the costs of getting metal guards to protect the trees. At the moment this is £75 + vat. He will try and get a cheaper quote. It was discussed whether a guard would be put round the "WI" tree. Mrs Merchant said this was not necessary as the WI would manage this themselves.

- Meeting regarding safety on the A30. Mr Jones and Mr Churchill attended a meeting with Haselbury Plucknett Parish Council, David Laws MP, Cathy Bakewell and a police representative. Many items were discussed but it was felt that any proposal should be kept simple. Some of the ideas included asking for a 40mph speed limit from West Coker through to the Haselbury Plucknett junction (obviously keeping the 30mph through East Chinnock). They also discussed double white lines. Mrs Bakewell is going to check whether you can actually have double white lines in a 30mph rural road. In 2010 the County Council are going to look at the whole of the A30 and talk to Parish Councils about what the issues are. The budget is limited but if anyone has any thoughts or comments they should forward them to the Parish Council before February next year. It was then proposed and seconded that East Chinnock request a 40mph limit from North Perrot / Haselbury Plucknett junction through to East Chinnock. This was carried 6 votes to 1. The Clerk was asked to e-mail this to Cathy Bakewell and Victoria Knight.
- Meeting with Highways department regarding Chinnock Hollow. Mr Churchill had circulated an in depth report regarding his meeting. In summary though it does not appear that a traffic or speed survey has been done (although people were seen for 2 days seemingly doing a survey of some sort). The road signs have not yet been repainted despite several requests but it is understood that the contractor has a backlog of work. It was reiterated that no action could be taken without the survey results. Mrs Bakewell will chase this up. There was a discussion over whether there are or are not plans for a priority system. However this was originally proposed about 16 years ago, so it was felt that any action plan should start from scratch

- Community Speed Watch Programme. The PCSO met with approximately 12 parishioners on Sunday 22nd November. There have been about 6 volunteers. Jeremy Churchill will be the official village Coordinator and Andy Sinclair the Communicator. The speed watch takes about an hour a time and is carried out during good weather and good light.
